Activity Agreement

I, the undersigned, on behalf of myself and or my personal representatives, heirs, next of kin, spouse, and on behalf of my minor child(ren) named below, DO HEREBY AGREE THAT:  
Equestrian Activities are Dangerous

(a) I RELEASE AND DISCHARGE THE MEADOWS OF MOORPARK EQUESTRIAN CAMP, INC., and its officers, directors, instructors, shareholders, agents, volunteers, employees, all landowners, immediately adjoining landowners and all and other persons acting on the Meadows of Moorpark behalf or in concert with them (hereinafter the "Released Parties") from any and all claims and liability, based on negligence, strict liability, failure to warn or otherwise, AND I AGREE TO HOLD HARMLESS, these parties for my injury, death, loss or damage to me (or my child), my horse(s) or any other person accompanying me, my animal or property, directly or indirectly arising out of or resulting from the riding, handling, or stabling of any horse (whether owned by me, Released Parties or otherwise), or in the presence of me (or my child) or my horse(s) or equipment on the premises of the Released Parties, or in any adjacent areas where horses are stabled, ridden, boarded or handled. I indemnify and hold prior mentioned Released Parties harmless from any loss, injury, damage, claim, punitive judgment or expense that Released Parties may incur arising out of my (and my child's) activities or presence on such premises or in such Meadows of Moorpark areas.

(b) PARTICIPATING IN, OBSERVING, OR BEING IN THE PRESENCE OF ACTIVITIES INVOLVING RANCHING/ HORSES or ponies, including riding, jumping, handling, training, boarding, stabling or care (whether or not under the supervision of an instructor), POSES DANGER AND RISK OF INJURY OR DEATH to people and livestock.

I acknowledge that: (1) worn and defective equipment, and other horses and riders are hazardous to me (and my child) and my horse(s); (2) I will continue to inspect the horses, riders, facilities and equipment, including the fences, corrals, arenas, hitching posts, roads, footing, trees, trailers, terrain, saddles, bridles, barriers or lack thereof, lighting or lack thereof, ranch vehicles and weather conditions; (3) the facilities, vehicles and equipment of Released Parties are not believed to be free of defects or deterioration; (4) the horses, riders, handlers and spectators may not be trained, knowledgeable or experienced; (5) instructors may incorrectly assess / supervise the skills, experience or ability of horse and rider, or the difficulty or danger of any jump course, riding exercise or activity; (6) the facilities have natural and unnatural hazards which include but are not limited to jumps, ditches, structures and other obstacles, hills, rocks, ponds, rodent holes, debris, low hanging trees, and falling branches; (7) horses on the property have been known to bite, buck, rear, kick, trip, bolt or misbehave without warning; and (8) the existence of dogs, birds, insects and other animals, trucks, tractors, motorcycles, helicopters and other vehicles, sirens and other noises in and around the area may pose increased hazards.

Nevertheless, I VOLUNTARILY ELECT TO ASSUME ALL RISKS connected with the entry of me (and my child) and/or my horse(s) onto the premises of the Released Parties and adjacent areas, and with participation in activities involving ranching, farming, livestock and horses.

(c) If any portion of this contract/agreement is held invalid, the balance shall continue in full force and effect. I have not signed this agreement in reliance on any representation or inducement of the Released Parties. Any mediation or legal activities will be conducted in the County of Ventura, State of California

I HAVE READ THIS DOCUMENT AND I UNDERSTAND IT INCLUDES A RELEASE OF CLAIMS FOR PERSONAL INJURY OR DEATH TO ME (OR MY CHILD), AND FOR LOSS, THEFT, OR DEATH.
